Dear Panel Members:

I. There is a proposal being considered by Congress that will severely inhibit the latest wave of historic preservation in our country. This proposal prepared by the Congressional Joint Committee on Taxation would change tax benefits provided by the Federal Historic Preservation Tax Incentive Program. This Program allows historic property owners to donate a perpetual conservation easement on their property to a qualified non-profit organization dedicated to historic preservation. At its heart, it is about encouraging historic property owners to take the steps necessary to ensure the survival of America's architectural treasures for the enrichment of future generations. The tax benefit provided by this Program is a cost effective measure that protects, in perpetuity, our nation's architectural heritage and is an important tool to preserving our nation's history.

It is not only my belief but the belief of over 340 citizens that have notified the Trust to date of their support of this important program.
